# INTRODUCTION

EARN

Learn Grow Services Inc (LGSI) was initially established as an administrative and financial vehicle to support the Learn+Grow project. The name of this project was subsequently changed to Food Plant Solutions and thus the mission and purpose of LGSI continues as previously for the new entity.

# FOOD PLANT SOLUTIONS – Project Profile:

Tasmanian agricultural scientist, Bruce French, has spent over 30 years on a voluntary mission to document information on the food plants of the world. From this, Bruce has established a plain English database of over 27,800 edible plants. The database contains a variety of information on the plants including; where they are found and their climatic zones. In addition to this a selection of plants contain nutritional information, photos, where and how to grow, edible parts and how to use.

Rotarian Buz Green, of the Rotary Club of Devonport North in Tasmania (D9830), recognised the potential of the food plants database in the war against malnutrition. A relationship was developed between the organisation behind the food plants database, Food Plants International, and Rotary to establish what was ultimately to become Food Plant Solutions Rotarian Action Group, operating as Food Plant Solutions (FPS). The project was formally established as the project vehicle in June 2007. Officially recognised by the board of Rotary International as a Rotarian Action Group in 2011 it has gained a significant international profile within Rotary.

FPS is the communication platform to create awareness, seek engagement from and empower both Rotarians and Non-Rotarians to develop and implement Food Plant Solutions in developing countries. The role of Learn Grow Services Inc. is to provide administrative support to Food Plant Solutions, which can include but is not limited to:

- Fund raising and funds management.
- Management of GST.
- Being the responsible entity for employment and the issues surrounding same including legal responsibilities, workers comp, insurance etc.
- Dealing with non-Rotary aid providers.
- Supporting FPS both financially and administratively as appropriate.

The prime objective of FPS is to provide resources, information and technical support to aid providers, whether they are Rotary, non-Rotary, government, non-government or other international organisations. This can be done by:

- Developing and maintaining guides that provide guidance to potential users, in using the database.
- Creating publications and resource materials through the use of the FPI database.
- Improving the process for extracting data from the FPI database.
- Sharing at no cost, publications and resource materials to aid providers for delivery in aid programs.
- Developing specific publications for aid providers, on a case-by-case basis.

# **Report from the Chair**

Now in its ninth year, the project with a new Chair – PDG Una Hobday, saw significant growth, with a strategic focus.

With the last point in mind, the committee developed Key Performance Indicators (KPI's) as a way of measuring our progress and aims. These were identified as:

- 1. Fundraising aim to raise \$50,000 per year.
- 2. Aim to have 3 signed Letters of Intent with program partners.
- 3. Create 4 field guides per year.
- 4. Raise awareness about the program both within and outside Rotary.

An on-going challenge has been our inability to quantify outcomes. With that in mind, in August we developed Letters of Intent that are drafted individually for each program partner. Since their introduction there have been 14 Letters of Intent signed, and this has created true partnerships, with agreed responsibilities.

Our focus on creating new publications with new partners continued, with field guides created for the Democratic Republic of Congo, Pakistan, and Northern Thailand, with the latter two also having been reviewed in-country.

In 2012 we undertook a pilot program with a partner in Vietnam, focussing on school gardens, which was well received and expanded to include two provinces. The outcomes to date have been extremely positive:

- The students at the schools enjoy the benefits of the plants they have grown as they are provided with a nutritious lunch each day.
- Families, seeing the benefits of the school gardens, are now duplicating them at home.
- The schools are saving money each month from not having to buy food, which means this money can be redirected to other necessities.
- There has been a significant increase in enrolments as parents feel more confident in the school's ability to provide nutritionally for their children, which in turns frees up the parents to increase their household income as they have more time to work.
- Malnutrition has significantly reduced one school has seen a reduction of 80%, another 95% IN ONE YEAR even with a significant increase in enrolments.

This program demonstrates the benefits of our approach and has raised significant interest from other major aid organisations and leaders in our field.

Following on from the outcomes in Vietnam, we received a Letter of Support from the Director General (Ann Tutwiler), of Bioversity International, the preeminent leader in our field. Based in Italy, they are the world's largest international research organization dedicated to conservation and use of agricultural biodiversity. For them to acknowledge our work and support us is a huge coup. It reaffirms the significance and value of our work.

Our program partner in Indonesia – Priscilla Hall Memorial Foundation - successfully applied for a Rotary Matching District Grant. With this money, 1000 copies of the Bahasa

version of "Potentially Important Food Plants of Indonesia" were printed. At the time of writing this report, over 800 of these guides had been distributed, with recipients including: Austrade, Salvation Army, YUM, British Women's Association Jakarta, ANZA and Rotary Club at Bali Taman.

In January, Bruce French received an Officer of the Order of Australia and Buz Green a Member of the Order of Australia. Bruce's was received for distinguished service to agricultural science through the provision of edible plant information for improved food security, nutrition, and improved health outcomes for people in developing countries. Buz's was for agriculture, horticultural sustainability and research, and to the community. Following directly from their work, Learn Grow, and then Food Plant Solutions, was born. Both awards, whilst completely separate were very well deserved.

A project in the Philippines is a good example of how our approach can be implemented in any environment. Near the end of 2013, an enormous typhoon hit the Philippines, destroying property and killing over 6000 people. Several Rotary groups joined forces to assist the rehabilitation of the district school – Paypay District School. As part of this process, a derelict kitchen garden was identified – this was not part of the agenda for rehabilitation. So as a bonus, information from Food Plant Solutions was shared, including the field guide written for the Philippines. The principal, science teacher, other teachers and parents have now adopted and understood the principles of shared kitchen gardens and their benefit to growing children. There was a hurdle – the grounds of the school were to become a rebuilding site with workers and trucks working on all the spare ground. The enterprising school community solved the problem with portable containers that they move from spot to spot as the buildings around them are rebuilt.

With funding remaining a constant issue, for the second year in a row the committee created a calendar to sell, with the aim of raising both awareness and funds. This proved to be a successful undertaking.

PDG Una Hobday attended Rotary International Convention in May / June, leading our activities. Una's engaging approach resulted in many contacts and enquiries, all of which were followed up.

Our challenges remain the same - funding and human resources. Our team of volunteers are critical to our success. Each one does an out-standing job and I take the opportunity to thank each of you, without you we would cease to exist.

#### Scope

## Una Hobday, Chair



Una trained as a nurse, working in a range of health associated positions including the Director of Nursing in two retirement villages in Tasmania and Western Australia. During this time Una gained a Graduate Diploma in Health Education and a Graduate Diploma in Professional Management. Una joined Rotary International in 1991 as charter President of a Rotary Club and has held many positions in Rotary International. In 1999/2000

Una was chosen as the first woman District Governor in Australia. In 2015 Una became the Chair of Food Plant Solutions Rotary Action Group.

## John Phillips, Public Officer
